WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for participation in the activities arranged through Buttonwood Art Space (BAS), I hereby release, waive, discharge and covenant not to sue Buttonwood Art Space (BAS), Buttonwood Financial Group (BFG) and/or Friends of Konza Prairie (FOKP) their officers, servants, agents, owners, and employees (hereinafter referred to as "releasees") from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in BAS activities, or while in, on or upon the premises where the BAS activities are being conducted, while in transit to or from the premises, or in any place or places connected with the BAS activities.

2. I am fully aware of risks and hazards connected with being on the premises and participating in BAS activities, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in BAS activities, and I hereby elect to voluntarily participate in the BAS activities, to enter upon the above named premises and engage in activities. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in BAS activities, whether caused by the negligence of releasees or otherwise.

3. I further hereby agree to indemnify and save and hold harmless the releasees and each of them, from any loss, liability, damage or costs they may incur due to my participation in BAS activities, whether caused by the negligence of any or all of the releasees, or otherwise.

- G. I agree to consign the artwork(s) listed below to BAS with the understanding that in the event the artwork(s) sells, I shall receive 50 % of the listed price below within 15 days of the close of the art event. I shall provide a signed W-9 form to BAS before such payment can be made.
- H. I agree that if any of my artwork in this exhibition sells outside of BAS or BAS website, it is still subject to the 50% commission to FOKP (for the duration of the exhibit only).
- I. I understand this exhibition is in person and my accepted artworks are to be displayed physically in the gallery. If I can't deliver my artwork to the gallery, my work will be removed from the exhibit.
- J. I understand that it is my responsibility to collect any unsold artwork after the close of the exhibition. BAS has the right to retain any artworks not picked up after 60 days from the close of the exhibition.
